- 5. Old Business:

- Payouts vs trophies Kathy McLean motioned to table the awards except for state indoor then Tobi will get estimates for plaques of consideration an email the prices for indoor. Dan Jasa 2nd. Motion carried.
- State & NFAA patches No NFAA patches because they are too expensive. Jerry Denker motioned to use the patches that were altered for MBH tournaments. The white ones for NFAA/MBH championship tournaments and the brown ones for MBH tournaments (non-nfaa). Dan Jasa 2nd. Motioned passed.
