



## ***CONSERVATION COMMITTEE REPORT***

**This month I wanted to let you know about a new Missouri Hunters Organization.**

It's called Missouri Hunters for Fair Chase. The mission statement of this group says; We are a group of Missourians dedicated to educating and promoting public awareness about issues that affect the health of big game animals in our great state.

Missouri Hunters For Fair Chase (MHFFC) was organized in 2016 in response to the growing threat that Chronic Wasting Disease (CWD) is having on the Missouri deer herd. I was contacted by one of the groups founding members and current secretary Steve Jones in July 2017. Steve is an avid hunter and outdoor writer in Missouri as well as an active member of the Conservation Federation of Missouri. Steve requested MBH support for the ballot initiative they are currently trying to get signatures for and get on the ballot for a statewide vote. I contacted MBH Board of Representatives via email about Steve's request and after some research and clarification the B of R voted to allow MHFFC to use our logo as a supporting member of the ballot initiative.

We did not take this vote lightly, I feel like your B of R gave this issue a lot of thought and some very good questions were asked about the impact this ballot initiative would have. The bottom line to me is the protection of Missouri's whitetail deer and deer hunting in our state. Chronic Wasting Disease grows and spreads persistently but slowly. It is more like a relentless, creeping smoldering fire than a wildfire. In parts of Colorado and Wyoming CWD has taken 40 years to cut deer numbers in half. It never grows quickly, but is incredibly persistent in the environment once established. While it may take a long time to affect deer numbers in our state this disease has an immediate effect on deer hunting and on the most important reason I hunt which is to eat the venison I harvest. Deer hunting regulations are being changed to harvest more deer in the areas of Missouri that already have infected deer so as to reduce the herd size in hopes of slowing the spread of CWD. If you harvest a deer from one of the CWD Management Zones it should be tested for CWD before you eat it. CWD infected deer should not be consumed because of the risk to human health. There are currently 41 Missouri Counties in the CWD Management Zone. Hickory County, where I hunt just got added to the zone this year because 2 deer from the county next door (St. Clair) tested positive for CWD. That means any deer I harvest from my property should be tested before I eat it. Test results can take up to six weeks so I will have to cut up and process my deer, freeze the meat, wait until I get testing results back and then hopefully I can eat my venison. If it tests positive for CWD I will throw it out because it's not worth risking my health to eat that meat. It really turns my stomach to think I may have to waste meat from a deer harvest. I enjoy hunting deer and I will continue to hunt because hunting and harvesting deer is the best way to manage the deer herd for CWD control that we know of at this time. I just must resign myself to the fact I may have to throw away any diseased deer I harvest. ## LARGE & SMALL GAME COMMITTEE

Bow Season is almost here and one way I like get ready, at least as far as my shooting skills go is to do a little "Stump Shooting". If you've never done it you should give it a try. Just grab your bow and some arrows with blunt or Judo points attached, then go for a walk. As you walk through the fields and forest pick out stumps, grass clumps, a leaf or anything else that stands out and take a shot at it. I usually shoot the Judo points which are basically blunt tips with some spring loaded wires wrapped around the blunt point. The spring loaded wires will keep your arrow from burying under the grass or leaves and make it easy to find after the shot. Practicing this way has several benefits. You learn to estimate range, concentrate on a small target, deal with uneven ground, shoot in different weather conditions, and varying light conditions. It's a lot of fun trying to hit a yellow leaf, mushroom, or walnut lying on the ground at an unknown distance. If you want to step it up a notch then make it an actual hunt. In August there are several animals you could be refining your stalking and shooting skills on. Groundhog, Squirrel, and Frog seasons are all open. There is also one other critter that has become a real nuisance on my hunting property in Southern Missouri; ARMADILLO'S! There is no hunting or trapping season for the armadillo. However, the *Wildlife Code of Missouri* specifies that damage-causing armadillos may be trapped or shot to prevent further damage. **Refer to 3 CSR 10-4.130 Owner May Protect Property; Public Safety of the Code for details and restrictions.**

These critters are really digging up everything in site on my Hickory County property. Almost any evening you can walk the fields and spy "possum's on the half shell" coming out of their burrows to dig some more in search of worms and insects. One recent August evening I was out stump shooting with my recurve and saw 3 of them. I failed to get a shot at the first two but was able to put the sneak on the third and get an arrow in it. That's when the circus started. I had made a good shot from about 15 yards but I used a field point which did penetrate all the way through, however didn't cause enough internal damage to slow it down much. When my arrow hit that armadillo it jumped straight up about two feet and hit the ground running towards a nearby Cedar thicket with me hot on his trail. It tried to dive into a hole but the arrow through its body prevented it from going down the hole. Crawling into the thicket and trying to get another arrow into that critter was a little chaotic, kinda like being at a three ring circus. I was finally able to kill it but not before it tore all the fletching off of the original arrow. I think next time I go armadillo hunting I'll use some old broadheads!

2. Fair Chase Representative – Jim Low gave a presentation on spreading diseases of the deer population. Disease is being spread from deer raised and breed by ranchers or high fenced breeding farms. Wants to use the MBH name as an organization supporter, volunteer for organization, and money donation for their organization.  
Voting was done via email and passed to use our MBH name as a supporter.  
They have a website for getting petitions, materials to share, and educate hunters/people. Google hunters for fair chase or Missouri for fair chase for more information.
3. Minutes of the last meeting- Minutes of January 2017 meeting were read and accepted as written.
4. Financial Statements-Motion made & seconded to accept as written. It was brought up to have an audit on the books.
5. Update club charters-Discussion about a club who has a charter is past due and owes for advertising on the calendar all year. Tobi will send a 30 day notice for payment.
6. Old Business:
  - a. MBH Youth Jamboree-Tobi will create tournament registration and Bill will create advertising flyer. All tournament locations can set their own line times. All scores need to be emailed to Kathy McLean by 9:00pm Saturday night so she can create final results. Tobi will email pre-registration spreadsheet and updated membership roster. She will also mail scorecards, key chains, waiver and membership forms. A motion was made and passed for the 2017 tournament to follow the class definitions as prescribed by NFAA that will be going into effect Nov. 1<sup>st</sup>.
7. Large & Small Game – Jeff gave an update Youth Bowfishing tournament. Jeff & Kurt plan to attend the CFM Affiliate Summit on Sept. 14 & 15th.
8. New Business:
  - a. State indoor items:
    1. Jeff Bexten – Motion & passed to give him \$300 plus NFAA/MBH membership fees in return for hauling & storing materials for 2017 & 2018. Note: he shot 2017 State Indoor for free.
    2. Awards – Discussion about ordering belt buckles for past 2 years winners to purchase if they can verify they won. Kathy will find out price of buckles and contact Tobi who will send out information via email to the board for a vote. Motion made and passed to order and use same awards as last year. Tobi will order plaques for 1<sup>st</sup> place and MBH medals for 2<sup>nd</sup> & 3<sup>rd</sup>. Medals for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> will be used for team event.
    3. Volunteers/outside help – Motion made and passed to continue to pay the same people and their expenses as last year.
    4. Late fee charges – Motion made and passed to keep the same prices as 2017 tournaments.
    5. Change of youth prices – Motion made and passed to charge \$25 for all cub, youth, and young adult divisions for all MBH tournaments.

6. Targets – Motion made and passed to order targets for tournament.
  7. Bales – Motion made and passed to purchase 36 bales and sell for 63% of cost for 1 bale and 57% of cost for 3 or more bales.
  8. Scorecards – Tobi will order as needed
  9. Name Tags – No
  10. Team early/late registration – Motion made and passed to have 1 line for team shoot which will start at 4:30pm. Pre-registration will be needed and a late fee of \$10 will be charged. Total maximum number of teams will be 36.
  11. Patches – Motion made and passed to use up the remaining patch inventory and then drop using them once we run out. If a shooter wants a NFAA state championship patch then MBH will have to order them but the shooter will have to pay for them.
  12. Key chains – Motion made and passed to order 400 keychains.
  13. New division cuts – Kurt discussed the NFAA division changes. Bowhunter, BHFSL, or Longbow divisions have been terminated. FSL division in Cub, Youth, & YA were also terminated. Traditional & Crossbow divisions are only offered in Adult classes. FSL & Olympic divisions were terminated from the Professional class but they added a Silver Senior & Master Senior division. All changes take effect November 1<sup>st</sup>. Go to NFAA's website for full details of the NFAA meeting.
  14. Indoor S3DA-Kathy McLean asked if the S3DA could have a championship on Friday night. S3DA shoots ½ a NFAA round. Kathy will come up with a formal proposal and send to Tobi who will email to the board for a vote.
  15. Motion made and passed to allow USA memberships vs NFAA memberships.
