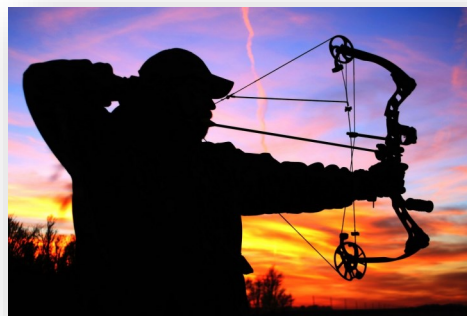

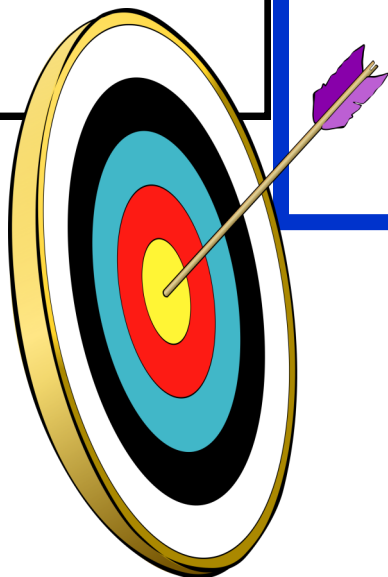
From the President

CONSERVATION COMMITTEE REPORT

On August 17th I attended the CFM Board meeting in St. James, MO.

Most of it was normal budget & event planning stuff but we also discussed the appointments of the next two Conservation Commission Board members. Gov. Mike Parson announced the appointment Steven Harrison, of Rolla, and Mark McHenry, of Kansas City, to the four-person commission that oversees hunting, fishing and forestry management.

Mark McHenry is the former head of Kansas City Parks & Rec as well as a lifelong conservation leader so no concerns there however Steve Harrison was an area of concern for most of us. Steve was the former president (2002 -2004) of the Missouri Big Game Farms and Breeders Association.

Steve Harrison is a dentist who also owns 2400 acres in Missouri and more land in Iowa. He is an avid hunter who has traveled the world hunting.

Steve was interviewed after his appointment by CFM Exe Director Tyler Schwartz and the CFM President Gary Van De Velde. Both Tyler and Gary asked Steve questions about deer farming and high fence hunting. Tyler and Gary believe that Steve no longer agrees with high fence hunting and believes that the MO Supreme Court made the right ruling when they said the MO deer are wild and under the authority of the Missouri Department of Conservation. At this time the CFM Board of Directors of which I am a member decided not to attempt to block the Steve Harrison confirmation by the MO Senate. As the political arena stands right now CFM does not have enough support to block Steve Harrison from being confirmed by the MO Senate. CFM will issue a press release neither supporting nor opposing the two new appointments but simply saying that CFM looks forward to working with the newest Conservation Commissioners. Those concerned with conservation in Missouri will be keeping an eye on the new Commissioner's performance.

Meeting Minutes the BofR Meeting

August 25, 2019

10:00 AM

1. Role Call- Charlie (Nomo), Kathy (East Fork), Bob (Northside), Jim (IBH), Cole (Springfield Complex); Pres, VP, Secretary, NFAA Rep, and Terry (Parliamentary)
2. Minutes of the last meeting – read and approved
3. Review financial statements – read and approved
4. Large & Small Game – Jeff is not here. We read his report from his email he sent to the board. Motion made and passed to pay the hotel room for the VP to go to the convention with Jeff B. Matt will get with Jeff for the information on the convention.
5. NFAA Director Update – Cole gave us the changes to outdoor format- reason of change was to shorten the amount of time on the range. The format change goes from a 14 to 12 target round, and eliminates all the fans and walk-ups. Amended item to be a test at the outdoor sectionals for 2020. A proposal for the junior members that belong to different archery organizations (i.e. ASA, S3DA, etc) to have a one year free membership to NFAA and then they pay for the renewal the second year. This is only for new junior members. At the meeting they turned down the motion to let juniors create a club charter. NFAA no longer allows arrow twirling. It was defeated to not have a defibrillator at every NFAA tournament. It is not a constitutional change but make it a policy issue. It will probably be at all NFAA tournaments and ran by professionals. Our state is down 30% as of December 31, 2018 in NFAA/MBH memberships. Next meeting will be in 2021.
6. Old Business:
 1. Youth – Nov. 9th - NFAA 300 round - at these locations: Springfield, Indian Trails, East Fork, and maybe Summit. \$5.00 a head hosting fee. \$25 entry fee.
 2. NFAA 450 – Nov. 30 and/or Dec 1 – at these locations: Springfield, Indian Trails (NFAA?), East Fork, IBH. \$5.00 a head hosting fees. \$25 for youth & \$35 for adults. Tobi will check with NFAA to see if a NFAA Commercial Lane charter is acceptable for hosting tournaments. Bill will check with Summit.
 3. Committee for changing MBH (Only) charters – Bill Myers, Kathy McLean, Amy Francka, & Cole Duensing. This will take a bylaw change. Motion made and passed to change the bylaws to read 3 head of household members to create a MBH (only) Club Charter. The President will create the new bylaw change and send it out via email for a vote.
7. New Business:
 - a. State indoor items:
 1. Bales (purchase/sold) – Motion made to purchase 25 bales. Passed. Motion made to keep the sale price the same - \$95 for one or \$86 for three or more providing the purchase price is the same as last year. Motion passed.
 2. Jeff Baxten (next year) - \$300 plus membership – same as last year.

3. Awards & keychains – Motion made to purchase 300 keychains. Passed. Same awards as last year.
 4. Volunteers/outside help - same old story. Setup on Friday. Etc.
 5. T-shirts – We have a lot left but they have the 2019 so maybe sell as donations. Motion made and passed to order 75 shirts with no calendar on the back but keeping the same front and selling for \$15. Kathy and Tobi will get together for what sizes to order.
 6. S3DA – Table to January

 1. Late fee changes – yes or no. No keep it \$10.
 2. Club/host fee % or fees – Tabled until bids come along

LARGE & SMALL GAME COMMITTEE

Woo Hoo!!! I was successful in the MDC Managed Hunt drawing. I get to hunt Longview Lake Park in Jackson County again this year. I hunted this hunt in 2017 and killed a doe the first sit to earn my buck tag and then spent the next two weeks watching several bucks in range while waiting for the big guy. Well the monster never showed but I did harvest a good 9 pointer on the last morning. It was a very successful hunt in my book and I'm exciting to hunt it again this fall.

Since I didn't draw any tags out west this year my season will be spent in Missouri chasing whitetails. Seems like a good time to rededicate myself to traditional archery, so I'll be hunting with my recurve this season. I'm sure this will limit my opportunities but bowhunting needs to be a challenge. I'll keep track of situations where I think I could have killed a deer with the compound as compared to what I actually get a shot at with my recurve and we'll see how they compare at the end of the season. Had a little tune up hunt in August while out stump shooting with my recurve. Armadillo's are a real nuisance on my Hickory County property, they are digging everywhere it seems but I rarely see them in the daylight. On August 15th I managed to sneak to within 20 yards of one digging in the front yard and made a good shot. A couple of years ago I did kill another Armadillo but was using field points on my arrow and that was not the best choice as I had to shot it three times and it ruined 2 arrows while fighting to get away. This time a broadhead on the tip of my arrow was much more lethal and the critter died quickly without damaging my arrow. Archery season opens in a couple of weeks!
