### LARGE & SMALL GAME COMMITTEE

I have received a few deer reports;

- 1. **Alan Boesch**, Rolla, killed a 60 lb. Doe on 10/13/19 with a 34 yard shot in Perry County. Archery deer # 69 in 55 years of bowhunting.
- 2. **Jeff Blystone**, Independence, harvested a 119 lb. Halloween Doe at 9:45 am with a 25 yard shot in Jackson County. Archery deer # 34 in 29 seasons.
- 3. **Tim Donnelly**, Springfield, used a recurve to kill a Halloween Doe during the evening of 10/31/19 with a 22 yard shot in St. Clair County.
- 4. **Alan Boesch**, Rolla, killed a 65 lb. Doe on 11/3/19 with a 13 yard shot in Perry County. Archery deer # 70 in 55 years of bowhunting.
- 5. **Alan Boesch**, Rolla, shot a 69 lb. Doe on 11/8/19 with a 25 yard shot in Perry County. Archery deer # 71 in 55 years of bowhunting.
- 6. **Jeff Blystone**, Independence, harvested a 135 lb. 10 pt. Buck at 3:30 pm with a 15 yard shot from his Black Widow Recurve on 11/10/19 in Jackson County. Archery deer # 35 in 29 seasons.
- 7. **Alan Boesch**, Rolla, shot a 75 lb. Doe (they're getten bigger) on 12/8/19 at 710 am with a 23 yard shot in Perry County. Archery deer # 72 in 55 years of bowhunting and forth kill this season for Allan.

Participation in the MBH Large Game Reports has decreased every year since the mid 2000's. Social media and the need for documented archery kills to prove that archery equipment is an effective means of killing deer is really no longer needed. So far this year I only know of 5 or 6 MBH members that have killed deer. MBH members are not hunting as much or no longer feel the desire to report they're kills. I have tried to increase participations with different incentives over the last couple of years but it's just not happening. I will continue to receive and list the reports I get in the MBH Release but the Large Game Awards program has been suspended for the time being. If you would like to see it continue in the future please let me or another MBH officer know what you suggest. The MBH Board meeting will be January 26<sup>th</sup> in Columbia, MO. Plan to attend if you have any ideas you would like to have heard by the Board of Representatives.

### CONSERVATION COMMITTEE REPORT

Conservation Federation of Missouri December Board Meeting Report- At the December Board meeting on the 7th we heard the news about closing the hog hunting in the Mark Twain National Forest and all cheered. I think the MO Farm Bureau getting behind hog eradication has helped the cause. At the meeting CFM Director Tyler Schwartz reported that 2.1 million acres has been saved from hogs since 2016! There are about 150 MDC and Federal Hog trappers working in the state and they are ramping up trapping in the Mark Twain National Forest since the December ruling. Hopefully they can make a big difference in the forest. MDC/APHIS have about got all the hogs killed out of the tri-lakes area. MDC/APHIS is now moving to what I call the "hard Ozarks" and will be running 50 trappers on a team in the field and rotating that team which is assigned 150 trappers. Lots of resistance over there with the locals. US Forest Service finally passed their ban but kept hog hunting during deer and turkey season. MDC Commission ordered the Department to change their regulation to the same. Tyler also talked about the 20k reward for elk poaching info and said he got that pledge from some "Major Donors" but didn't reveal his donors. CFM Budget ended in the black this year for the first time in many years and next years proposed budget is also black for a change. I think the biggest positive for the budget this year was the fact that the CFM office was short staffed for much of the year; it is fully staffed now so we'll see what happens next year. You should check out the new Legislative Action Center on the CFM website at https://www.confedmo.org/ and click on Legislative Action Center. It's much improved and simpler this year and hopefully more folks will use it to speak out. 2020 is CFM's 85th anniversary! We also got a report from CFM lobbyist Kyna Iman about possible upcoming issues in Jeff City. The session starts on January 8th. You can check out all that stuff on the Legislative Action Center.

The only rumbling I've heard about for the Archery and Shooting Sports Committee, which I chair, is a possible resolution or statement of support for Senate Bill 662 which is trying to make it possible for Share the Harvest to handle "shelf-stable meat sticks" to be passed out for kids back pack meals at schools, churches, and food banks. Currently STH can only handle "frozen meat" according to previous legislation.

It was also just announced that the Rock Island Railroad corridor will become park of the Missouri State Parks System. So more trails to hike & bike in Missouri coming soon.

We ended the meeting with the Mega Raffle Drawing. About 500 tickets sold at \$50 each for eight nice prizes. Grand Prize of the G3 Boat, motor, & trailer was won by Jim Keeven of Holts Summit with ticket #729.
