Duties of MBH Officers

CONSERVATION COMMITTEE

This year, MDC is revising its 10-year Deer Management Plan. As part of the plan revision process, we are holding a meeting this June with select MDC partners to offer an opportunity to provide feedback on the draft plan's goals and objectives. The meeting will be held at the Central Regional Office and Conservation Research Center in Columbia

I was invited to participate in a meeting representing MBH and The Conservation Federation of Missouri (CFM) along with CFM Executive Director Tyler Schwartz and CFM Big Game Committee Chairman Steve Jones. We were invited by Jason Isabelle (MDC Cevid Program Supervisor) along with representatives from The National Deer Association, Missouri Farm Bureau, BackCountry Hunters & Anglers, US Forest Service, University of Missouri Animal Science, and several MDC specialists in animal diseases, communication personnel, protection personnel, and a wildlife division chief.

Our purpose was to review the deer management, provide comments, and to get feedback from the CFM RAC committee members and return our comments to MDC by July 5, 2024. This meeting and comment period was a preview to the comment period which has already opened to the general public. That comment period will be open through August 4, 2024. Here is the feedback that CFM submitted.

Name and Affiliation of Partner: The Conservation Federation of Missouri.

These positions were taken from a combined meeting of the CFM Big Game, Wild Turkey and Furbearers Committee, the Archery and Shooting Sports Committee (chaired by Steve Jones and Jeff Blystone respectively) and interested members from the current officers and the Board of Directors.

Goal 1: Deer Population Management

- 1.5.1 Regarding DMAP, we have heard and are very encouraged that the minimum property size has dropped from 500 to 250 acres. We further believe that any program designed to connect deer hunters with landowners willing to let them hunt should receive extra focus for DMAP users.
- 1.5.4 We support this strategy

Goal 2: Hunting and Recreation

- 2.1.5 We support creating field to fork type educational programs, either as events, live training, or publications/videos.
- 2.2.5 We encourage MDC to increase the focus on carcass movement restrictions, and to perhaps elevate reporting them to the highest level of potential OGT rewards.
- 2.4.3 We support this and would add that under-used public hunting opportunities on public lands should be highlighted, especially in areas where deer management goals are not being met.
- 2.5.3 We encourage changing the deer tag purchase system to add the option to include a voluntary donation to Share the Harvest, for instance in multiples of \$1.
- 2.5.4 This strategy caught our attention, but we would need more detail before supporting or opposing.
- 2.6.2 We support this, provided it is implementation does not conflict with 2.5.5.

Goal 3: Deer Health and Disease

3.1 & 3.2 - General strong support. While many things about CWD remain consistently complex, and the battle is not yet going our way, MDC remains at the cutting edge of best practices for responding to CWD. We commend and support the Department and the Commission for the unflagging focus on the problem.

We do hope that the department expands the freezer-drop off CWD testing program at least to include all CWD counties

- 3.3.1 We concur but would point out It's over 6 years since the Missouri Supreme Court clarified that the MDC has primary regulatory authority over all cervids and other game species in Missouri, both free-ranging and confined. We understand that the regulatory landscape is complicated, involving the Missouri Department of Agriculture and the USDA. We encourage the Conservation Commission to remain mindful that their constitutional mandate to manage the fish, forests and wildlife for the benefit of all Missourians should remain their highest priority as they interact with other agencies.
- 3.3.2 We suggest that detailed data related to confined cervid escapes should be organized and made publicly available on the MDC website.

Regarding all of section 3.x, we presume that the MDC and the conservation commission remain in active communication with wildlife agencies in other CWD states, possibly in conjunction with the Southeastern Cooperative Wildlife Disease Study and The Association of Fish and Wildlife Agencies. We encourage such communication to ensure that all consider emerging ideas for CWD management as early as possible.

Goal 4: Education, Communication, and Public Engagement Objective 4.1:

It seems likely that in 2034, the next time this plan is reviewed, CWD related challenges are likely to seem dramatically different than they are in 2024. It certainly seems that way now looking back on 2014. We suggest a pro-active effort to research the "Human Dimensions" aspects of how hunter attitudes and behaviors change in response to the continuing spread of CWD. This could be an advantage in adapting your communications to best achieve the goals related to CWD.

4.1.6 – More effective education and publicity about carcass moving within the state or from out of state. Tell hunters how and where to leave carcasses or provide disposal locations for carcasses.

Objective 4.2 - Overall opinion for this objective: Strive to improve the effectiveness of public education regarding CWD. Most important is to target the counter-arguments (e.g. CWD has always been here, it's ok to discard carcass parts outside, etc). MDC has a powerful and effective "Communication" branch, but this thorny problem may call for some thinking outside the box. One idea might be to treat this as a cross-branch effort, involving input from other branches such as Protection, Science, Community and Private Land Conservation.

Goal 5: Research

Objectives 5.1 & 5.2: We support all strategies in both Objectives

NOTES

We have one specific recommendation that is possibly out of scope for the 10 year plan. We believe it urgent that the MDC or the Commission should contact the wildlife agencies of the other 5 states bordering Oklahoma (TX, NM, AR, KS, & CO) and form a collective opposition to Oklahoma's announced plan to release deer selectively bred for "Disease-Resistant PRNP Variants" into the wild. Getting the Association of Fish & Wildlife Agencies involved might be even better.

As you know, this terrible plan is based on the false premise that these deer are immune to CWD. In fact though they may be slightly more resistant to infection, and may live a bit longer when infected, they also spread the infectious prions over their habitat for a longer period than other deer. If Oklahoma insists on going forward, we believe the risk to the resources managed by Missouri and the other 5 states could be significant. All means of discouraging this plan should be pursued, including by lawsuit if feasible.
